

INFORMATION ABOUT THE CASES:

- The investigation has been launched under Paragraph 1, of the Article 126 of the Criminal Code of Georgia (CCG) on the fact of alleged violence against the Journalist of TV Pirveli on the territory adjacent to one of the election districts. The person responsible for committing the alleged crime was identified; the relevant investigative and procedural activities are underway to bring criminal charges against the mentioned person;
- The investigation has been launched under Article 162¹ paragraph 1 of the CCG, on the fact of alleged violence against the representative of the opposition party on the territory adjacent to one of the election district in Mtskheta. The sides of the incident have been questioned, that speak of the different versions of the fact;
- The investigation has been launched under Paragraph 1, of the Article 187 of CCG on 2 facts of damaging the tires of a vehicle belonging to the representative of the opposition party. The operative and procedural activities are underway to identify the persons responsible for the crime;
- The investigation has been launched under paragraph 1 of the Article 162¹ of the CCG, on 2 facts of physical abuse of the representative of the ruling party. The victim and witnesses having information on the case, have been questioned. At this stage, questioned persons do not have information about the identity of alleged criminal offender. Investigation and procedural activities are being conducted in order to assess criminal offenders;
- Investigation has been launched under the Article 164² of CCG on the case of the attempt of repeated voting in Kvemo Kartli. 9 such cases were revealed, relevant persons are being questioned;
- Investigation has been launched under Paragraph 1 of the Article 126 of CCG on the case of physical abuse in Tbilisi, Lilo settlement. The victim has been questioned. Operative-investigative activities are being conducted in order to reveal the identity of perpetrator;
- Investigation has been launched in the election precinct of Abasha, district №10, under the Article 164 of CCG on the case of the alleged breach of the secrecy of the ballot by the member of Sakrebulo from Georgian Dream. Relevant investigative activities are being conducted;
- Investigation has been launched under Paragraph 1 of the Article 177 of CCG on the case of theft in the election district in Dusheti;
- Regarding the fact that took place in Chumlaki, investigation has been launched under Paragraph 3 of the Article 236 of the CCG. At this stage, on the basis of witnesses' interviews, abovementioned does not have any connection with the election and there is no sign of political motive. Shooting took place at the certain distance from №19 Chumlakhi election district. Shooter under influence allegedly used flare gun. The forensics criminal expertise has been appointed, at the stage no signs of crime have been identified;
- Investigation has been launched under of the paragraph of the Article 162¹ of the CCG on the alleged physical abuse of the representative of the opposition party. The victims and the witnesses have been interviewed, the forensics expertise has been appointed;

- Investigation has been launched under paragraph 1. of the Article 187 of the CCG on the fact of damaging the vehicle belonging to the representative of the opposition party. The victim has been interviewed, the forensics criminal expertise has been appointed;
- Investigation has been launched under Paragraph 3 of the Article 177 of the CCG on the fact of theft of the car plate number of the observer of the opposition party at the territory adjacent to the election district in Gori. The victim and the witness have been interviewed;
- Investigation has been launched under paragraph 1 of the Article 162¹ of the CCG on the fact of physical abuse of the supporter of the opposition party on the territory adjacent to the election district in Bolnisi. The initiator of the notification has been interviewed. At the current stage no fact of physical abuse have been proven;
- Investigation has been launched under Paragraph 1, of the Article 160 and Article 163 of CCG on the fact of unlawful entry into election district and interference with the work of electoral commission from the side of opposition representatives in Rustavi,. Operative activities are being conducted in order to reveal the identity of perpetrator;
- Investigation has been launched under Paragraph 1 of the Article 162¹ and Paragraph 1 of the Article of 187 of CCG on the fact of violence against opposition supporter and damage of his vehicle on the territory adjacent to the election district in Rustavi. Witnesses are being questioned and investigative activities are conducted;
- Investigation has been launched under Paragraph 1 of the Article 162¹ of CCG on the fact of violence against the observer from ruling political party in Tbilisi, Gldani district;
- Investigation has been launched under Paragraph 2 of the Article 239 of CCG on the fact of hooliganism by opposition representatives on the territory adjacent to the election district in Marneuli, village Imiri,;
- Investigation has been launched under Paragraph 3 of the Article 236 of CCG the fact of alleged shooting from firearm on the territory adjacent to the office of oppositional political party. Relevant persons are questioned. Starter weapon was seized. The forensics examination has been appointed. At this stage, criminal offence is not proved;
- Investigation has been launched under Paragraph 1 of the Article 162¹ of the CCG on the fact of violence against opposition representative at the election district in Bolnisi;
- Investigation has been launched under Paragraph 1 of the Article 126 of CCG on the fact of violence against the journalist of “on.ge” at the election district in Tbilisi, Didube district;
- Investigation has been launched under Paragraph 1 of the Article 187 of CCG on the fact of damaging the window at the election district in Tbilisi, Gldani district.

Investigation is being conducted on all of above mentioned cases in order to prove/deny criminal offence, to identify perpetrators and prosecute. At this stage, obtained evidences reveal alleged criminal offences by the representatives of both, oppositional and ruling parties.

It should be mentioned, that in order to avoid interference in electoral process, at the starting stage of investigation witnesses, fulfilling official duties at the election districts, have not been questioned.

Investigative and procedural activities are being intensively conducted on each case-witnesses are being questioned, forensics examinations are being appointed. Society will be additionally informed about the progress of investigation in the nearest future.
